
1. Investiture of the Board Member 2023 – 2024 and Valedictory for the Board 2022 – 2023

The Commerce Chronicles is the newsletter which is complied and published by Kairos every month with sole focus on the theme of commerce, to help students stay up to date with the world of commerce.




Highlights of the events 2022 – 2023






3. Quest Magnet
